First is Alt-U, Paragraph tab, and click on the Parenthetical paragraph; click on advanced. Check to be sure that the "Behaves as" is set on parenthetical. Why you might ask? When running your spell checker, have you ever noticed that it sometimes stops on the same speaker with a parenthetical in between? No longer. Your spell checker will now glide on by.

How about "Clean Playback"? Let's assume for a minute that you have changed your listening speed while editing or your threshold settings and can't quite understand what someone might be saying, so now you need to listen to this passage at normal speed – What do I do?

No problem. It's so easy!!

Go to tools – multimedia – Control Panel -- and there is a "Clean Play" function, which returns your audio file to its normal settings without compromising your settings just for that one brief moment...simple, fast, and reliable.

## **Case CATalyst Internet Search**



Before the days of the Internet, many hours were spent in research. Every reporter had a personal library of dictionaries and reference works, including medical dictionaries and legal dictionaries, Physician's Desk References, Zip Code Directories, Atlases...... anything that would speed up the process to find a spelling. Investing in those books

is a thing of the past with the invention of the Internet. (In my personal opinion, it's the greatest invention of our time.) Countless hours have been saved by a click of a mouse and the information is right at our fingertips.

Starting with CATalyst version 8.0, a feature was added that allows you to do an Internet search right from within Edit. (Only if you have an active Internet connection, of course.) CATalyst will connect to the search engine of your choice, display the word or phrase in the Text field, and display the search results.

The default search engine is Google, but if you prefer another search engine, that can be changed by going to your UserSettings.ini file and specifying which search engine you prefer. The instructions for changing your user settings can be found in the CATalyst Help section under Set Internet Search Engine.

There are several different ways to access the Internet Search.

From the Edit menu (Alt E/n)

Right click, Internet Search

Assign a key combination to your keyboard map or EZ Keys

Open a file. Highlight a word of phrase for which you would like to do an Internet search.

From the Edit menu, (Alt E/n) click Internet Search.

CATalyst will automatically display the Google results from the Google Web site. You can browse through the Web pages by clicking on the desired search result.

## **Depo Advisory Committee**

This year the goals of the Depo Advisory Committee were to increase freelance membership in CCRA, to promote CCRA as representing and protecting freelancers, to address the issues facing freelancers in protecting our industry, to encourage professionalism, to educate freelancers especially in the area of technology, to increase income for CCRA, and to increase freelance representation on the CCRA Board of Directors.

The Depo Advisory Committee was heavily involved this past year with helping to write the language for AB 1211, which clarifies in law the attorney's responsibility to timely pay reporters for their reporting services. CCRA and our lobbyist Lisa Kaplan worked very hard in conjunction with DRA and their lobbyist Ed Howard, and the bill was signed into law in July and takes effect January 1, 2008. We are very pleased with the passage of this legislation by unanimous consent through both houses of the legislature.

Also during the year we had the opportunity to provide opinion and input on various matters of the Court Reporters Board's strategic plan, including issues regarding audiosync and continuing education for reporters.

This committee has been instrumental in answering members' questions posed on the "Ask A Reporter" feature of the CCRA Web site, helping many reporters with the day-today performance of their jobs and the quirky and uncommon scenarios that sometimes arise.

Committee members provided informative articles for publication in our CCRA Online magazine, including monthly Depo Daze articles.

We have continued our work on our goal to revise and republish a Deposition Manual as a reference for reporters and students throughout the state, carefully culling through code sections and determining best business practice recommendations for reporters and depo firms, and

#### **Judicial Procedures Committee**

The Judicial Procedures Committee monitors the activity of several governmental entities responsible for revising and rewriting codes and statutes. Our goal is to identify changes that may affect court reporters, official and freelance, and to recognize opportunities those changes may present. John Avery and myself, Tom Pringle, are the committee.

Among the entities we watch are:

The Judicial Council has several committees working overtime to come up with proposed changes to the Rules of Court and statutes and new legislation. Proposals are periodically published for public comment; that's where we come in.

In February of 2007, CCRA requested a presence on one of those very committees: The Technology Advisory Committee. Earlier in the year, we had approached the council informally and our request was denied. This letter was a more formal request for reconsideration for the council to approve a court reporter member or liaison for the Technology Advisory Committee.

In spite of the fact that this committee is recommending changes that directly affect reporters and the fact that reporters are typically the most tech-savvy employees in the courtroom, the Judicial Council denied our request.

In April of 2007, CCRA submitted comments in response to a proposed amendment to Judicial Branch Education: Minimum Education Requirements, Expectations and Recommendations, SP07-01. It was our request to add CCRA to the list of approved providers for continuing education required by the court in rule 10.481(a). This is a new rule requiring at least two hours per year of continuing education for court employees.

Even though no training for official court reporters is provided on a statewide basis, our request was denied. Therefore, official reporters who do not want to sit through an hourlong session on how to pick up a box, etc., may want to consider CCRA seminars and convention for reporter-specific education; however, because the council has refused to put us on the approved provider list you will have to get approval locally beforehand.

In June of 2007, CCRA submitted comments in response to Proposals for Changes to Rules, Standards, Forms and Judicial Council sponsored Legislation - SPR07-01 through SPR07-36 as follows:

#### SPR07-02, Records in Civil and Criminal Cases.

This proposal applies to civil and criminal cases and would add a new rule that clearly lays out all the different options for providing the record of oral proceedings from the trial court. We suggested adding the caveat "if available" when designating a computer copy of a transcript on appeal.

Our concern was, and is, that there may be a handful of reporters not on computer systems. Also, our experience tells us that when dealing with anything digital, difficulties can, and do, arise from time to time which can make a computerized record unavailable.

#### SPR07-05, Miscellaneous Appellate Rules.

Rule 8.155 pertains to augmenting and correcting the record. The proposal is that under (2) a new sentence would be added, "The pages of the attachments must be consecutively numbered."

Here the concern was, consecutive to what? It is ambiguous. It could be consecutive to each other or to the previous augment or to the end of the trial transcript or ... There are 58 counties in California that have 58 different appellate clerks who all have a different way of doing things, so very little can be left to the imagination.

### LEG07-02, Governmental Fee Exemption (Amend GC section 6103)

The Judicial Council proposed to clarify this law by amending the statute to expressly state that it does not apply to civil jury fees or jury deposits. We suggested that while they were at it, why not clarify that this law also doesn't apply to transcript fees.

As of September 12, 2007, when this report was written, there were no new proposals requiring comment on the Judicial Council Web site.

June was a busy month for the Judicial Procedures Committee. On June 15, CCRA responded to an April proposal from the California Law Revision Commission re: Comments to Technical and Minor Substantive Statutory Corrections: References to Recording Technology. The proposal was to correct and modernize existing references to audio and video recording; specifically, the use of "tape" and "cassette" would be revised to a generic term.

But the Commission also invited comment whether recording using technology that "does not record on an easily identifiable and segregable medium" is a substantive change to those PC sections. Specifically, the Commission asked, "If such technology is used, would it be more difficult for the court to control access to the recording, increasing the likelihood of a breach of privacy?"

CCRA responded that, indeed, the Commission should be very concerned. We directed the Commission to an article written by Robin Springer for SpeechTechMag.com posted May 1, 2007. In a nutshell, this article says, in part, "Because digital information can be so easily manipulated

without physical signs of tampering . . . we have entered an era ...in which, 'you can't believe anything you see or hear anymore.'"

"In response, courts may find that, because digital audio recordings lack the indicia of trustworthiness magnetic audiotape recordings have, the probative value of digital recordings is so diminished their introduction into evidence should be curtailed."

CCRA's position is that digital recording has advanced to the point where it represents a risk to the integrity of the record. It is obvious that to substitute digital recording for a court reporter is removing a time-proven and trustworthy layer of security and putting the integrity of the appellate record in jeopardy.

In addition, the Judicial Procedures Committee, in collaboration with Sandy VanderPol, CCRA's President, made several recommendations as follows:

- 1. Offer text streaming to the web for Judicial Council business meetings;
- 2. Utilize the public comment portion of the Council's meetings to present ideas, concerns, and issues;
- Take advantage of the opportunity the new CE requirements present to educate official reporters on the value of customer service/adopting a businessperson perspective to court positions;
- 4. Develop a pilot project for pro bono work in conjunction with the Open Community Courts program in Orange County, a program that contains a number of outreach programs in an effort to improve access to the courts in Orange County. Our idea was for reporters to volunteer one day a month to the appropriate program.

It turned out that the outreach programs in No. 4 were not well-suited to our concept, but I wanted to include it in this report because of the overwhelmingly positive response on the part of the official reporters in Orange County.

As part of this process, CCRA's Judicial Procedures Committee has reviewed thousands of pages of proposed rule changes and statutory revisions. This report attempts to capture some of the activity of the Judicial Procedures Committee on your behalf. It has been an honor and a privilege for John Avery and myself, Tom Pringle, to serve you all in this fashion.

## **Legislative Committee**

Great News - AB 1211 (Price) Signed into law!

On Friday, July 27, 2007, Governor Schwarzenegger signed into law AB 1211, a bill cosponsored by CCRA and DRA. This new law will become effective on January 1, 2008. (This bill would make the attorney responsible for payment of products and services provided by the deposition officer and/or the firm rather than the party.)

First and foremost, I would personally like to thank the many dedicated volunteers who made themselves available to work this bill through the legislature. Many of you wrote letters to the Assembly and Senate Judiciary Committees and to our Governor to support this bill. Your effort truly made a difference in the eyes of the legislators and the governor.

Thanks to our Deposition Advisory Chair, Sheri Turner, and the committee members – Bill Greenley, Kelly Roemer, Lynden Glover, Paula Killion, Craig Wood, Mark Brickman, Jan White, Rose Goni and Ray Eggebraaten – for their time spent on the specifics of the language in the bill, the amendments thereto and the analysis of the bill as it worked its way through the legislature.

Special thanks to Lisa Kaplan, CCRA's lobbyist, who dedicated many hours to this bill. Lisa spent hours walking the halls of the Capitol educating the appropriate committee members and their staff about AB 1211, writing support letters, meeting with trial lawyers' lobbyists and much more.

Additionally, CCRA thanks Curren Price, Jr. for his authorship of AB 1211 and specifically Cliff Costa, Assemblyman Price's staff person assigned to this bill.

#### AB 582 (Evans)

AB 582 is the bill that would give official reporters a raise on their transcript fees, both the original and one and the copy rates. This bill is authored by Assemblywoman Noreen Evans, who was a transcriber for court reporters during her college years. Sponsoring AB 582 is SEIU, the union that represents many of the official court reporters throughout the state. CCRA has been instrumental in supporting the efforts of SEIU in getting this bill passed.

Assembly Member Evans has been a strong advocate for official reporters receiving a raise. After all, it's been 17 years since there's been a raise on the O + 1, and 103 years since there's been a raise on the copies!

Currently AB 582 is located in the Senate Judiciary Committee (SJC) and will be "parked" there and taken up next year. During next year's legislative session, CCRA will, once again, be working with SEIU to move this bill forward.

One of the main reasons for AB 582 stalling in the SJC results from the state's budget shortfall. Next year CCRA will be working tirelessly with SEIU to get AB 582 passed. Quoting Michelle Castro, SEIU's lobbyist: "We've come a long way and have gotten over some really major hurdles, but there are still some that we just can't overcome this year."

Please see below the additional bills that CCRA and your lobbyists have been tracking this year.

### AB 32

(Fuller [R]) Career technical education: work certification training.

**Status:** 06/01/2007-Failed Deadline pursuant to Rule 61(a) (5). Last location was APPR. SUSPENSE FILE

Current Location: 06/01/2007-A 2 YEAR

**Summary:** Existing law requires school districts to adopt a course of study for grades 7 to 12, inclusive, that includes, among other things, career technical education. This bill would state the intent of the Legislature to provide, within the public school system, work certification training options to pupils who are between the ages of 16 and 18 years, have passed the high school exit examination, and have the consent of their parents or guardians, with particular emphasis on job specific skilled labor and technical training. This bill contains other related provisions and other existing laws.

#### AB 159

(Jones [D]) Courts: judgeships.

Status: 09/10/2007-Read third time, passed, and to Assembly. (Ayes 39. Noes 0.)

Current Location: 09/10/2007-A ASSEMBLY

**Summary:** Existing law requires the Governor to submit to a designated agency of the State Bar of California the names of all potential appointees or nominees for a vacant judicial office for evaluation of their judicial qualifications. Upon receipt of those names, the State Bar is required to evaluate and determine the qualifications of each candidate for judicial office and to report in confidence to the Governor its recommendation whether the candidate is qualified, as specified. This bill would require the State Bar to consider legal experience of candidates broadly. This bill contains other related provisions and other existing laws.

#### AB 299

(Tran [R]) Maintenance of the codes.

Status: 07/27/2007-Chaptered by the Secretary of State, Chapter Number 130, Statutes of 2007

Current Location: 07/27/2007-A CHAPTERED

Summary: Existing law directs the Legislative Counsel to

advise the Legislature from time to time as to legislation necessary to maintain the codes. This bill would make technical, nonsubstantive changes in various provisions of law to effectuate the recommendations made by the Legislative Counsel to the Legislature.

### AB 310

(Silva [R]) Maintenance of the codes.

Status: 09/06/2007-Enrolled and to the Governor at 6 p.m.

Current Location: 09/06/2007-A ENROLLED

**Summary:** Existing law establishes the California Law Revision Commission. Existing law authorizes the commission to recommend changes in the law as it deems necessary to modify or eliminate antiquated and inequitable rules of law and bring the law into harmony with modern conditions. This bill would make technical and minor changes to various laws.

#### AB 500

(Lieu [D]) Civil actions: telephonic appearances.

Status: 09/10/2007-Enrolled and to the Governor at 6:15 p.m.

Current Location: 09/10/2007-A ENROLLED

Summary: Existing law permits attorneys to make appearances by telephone at trial setting conferences, except as specified. This bill would permit a party to appear by telephone in any conference or hearing at which witnesses are not expected to be called to testify. The bill would require the party choosing to appear by telephone to provide notice in either the moving or opposing papers or by oral or written notification at least 3 court days before the appearance. The bill would permit a court to provide teleconferencing appearances by entering into a contract with a private vendor, pursuant to which the vendor would be permitted to charge a party appearing by telephone a reasonable fee, and would also permit a court to require a particular call provider to be used for telephone appearances. The bill would require a court to publish notice providing the information necessary to appear by telephone at conferences and hearings. The bill would also specify the application of these provisions to probate proceedings.

## AB 582

(Evans [D]) Court transcription fees.

Status: 06/21/2007-Referred to Com. on JUD.

Current Location: 06/21/2007-S JUD.

**Summary:** This bill is sponsored by SEIU with CCRA and COCRA actively working with SEIU. This bill would provide for

an increase in the folio rates for transcripts prepared by the official court reporter and official reporter pro tempore. This bill would also create a statewide uniform transcript format.

#### AB 863

(Davis [D] ) Los Angeles County Superior Court employees.

Status: 09/05/2007-To inactive file on motion of Assembly Member De Leon.

Current Location: 09/05/2007-A INACTIVE FILE

Summary: Existing law provides that each trial court may establish a salary range for each of its employee classifications, and considerations shall include, but are not limited to, local market conditions and other local compensation-related issues such as difficulty of recruitment or retention. This bill would require the Los Angeles County Superior Court to pay each employee in a bargaining unit represented by any specified employee organization an amount equivalent to the additional amount the employee would have received if the reclassification raise the employee received on October 1, 2005, had been retroactive to August 1, 2005. The bill would also provide that the Legislature urges the Los Angeles County Superior Court to act in a responsible manner and disburse the funds, which are currently held by the Administrative Office of the Courts, as directed for the purposes of paying the amounts prescribed in this act.

#### AB 1025

(Bass [D]) Professions and vocations: licensure.

Status: 08/31/2007-From committee: Do pass. (Ayes 9. Noes 7.) . Read second time. To third reading.

Current Location: 08/31/2007-S THIRD READING

Calendar Events: 09/11/07 64 SEN THIRD READING FILE

Summary: This bill pertains to court reporter licenusre, among other vocational licenses, and would provide that a person may not be denied licensure based solely on a criminal conviction if the person has been rehabilitated, as specified. The bill would also provide that a person may not be denied licensure or have his or her license suspended or revoked solely based on a criminal conviction that has been dismissed on specified grounds, unless the board provides substantial evidence, as specified, justifying the denial suspension, or revocation. The bill would require the board to provide an applicant or ex-licensee whose application has been denied or whose license has been suspended or revoked based upon a crime with a copy of his or her criminal history record, as specified. The bill would require the board to maintain specified information pertaining to the provision of criminal history records and to make that information available upon request by the Department of Justice or the

Federal Bureau of Investigation. The bill would require the department, to prepare annual reports to the Legislature documenting the board's denial, suspension, or revocation of licenses based on the bill's provisions.

### AB 1211

(Price [D] ) Depositions: costs.

Status: 07/20/2007-Chaptered by the Secretary of State, Chapter Number 115, Statutes of 2007

Current Location: 07/20/2007-A CHAPTERED

**Summary:** This bill would provide that the obligation to timely pay the deposition officer or entity providing the services of the deposition officer for that transcription, and any other deposition products or services that are requested, shall be the responsibility of the requesting attorney or a party representing himself or herself, unless responsibility for the payment is otherwise provided by law or the deposition officer or entity is notified in writing that the party or another identified person will be responsible for payment. The bill would provide that these provisions do not prohibit or supersede an agreement between an attorney and a party allocating responsibility for the payment of deposition costs to the party.

#### AJR 38

(Levine [D]) Training for Realtime Writers Act of 2007.

Status: 08/27/2007-Referred to Com. on JUD.

Current Location: 08/27/2007-A JUD.

**Summary:** This measure would urge the Congress of the United States to enact legislation that would provide competitive grants for training court reporters and closed captioners.

#### SB 45

(Perata [D]) Private postsecondary education.

Status: 09/10/2007-Read third time. Passed. To Senate.

Current Location: 09/10/2007-S SENATE

**Summary:** Our private court reporting schools are governed by the former Private Postsecondary and Vocational Education Reform Act of 1989, which became inoperative on July 1, 2007, and is to be repealed on January 1, 2008, generally set minimum standards of instructional quality, ethical and business practices, health and safety, and fiscal responsibility for private postsecondary and vocational educational institutions, as defined. This bill would extend these provisions so that they apply until December 31, 2008.

## SB 145

(Corbett [D]) Court facilities.

Status: 09/06/2007-Withdrawn from committee. Ordered placed on third reading.

Current Location: 09/06/2007-A THIRD READING

Calendar Events: 09/11/07 56 ASM THIRD READING FILE

Summary: Existing law requires the Judicial Council, in consultation with the superior court of each county and the county, to enter into agreements concerning the transfer of responsibility for court facilities from that county to the Judicial Council. Transfer of responsibility may occur not earlier than July 1, 2004, and not later than June 30, 2007. Existing law requires counties to remit to the state, for deposit in the Court Facilities Trust Fund, county facilities payments composed of the costs of various items related to court facility operation and maintenance. This bill would extend the deadline for the transfer of responsibility for court facilities to December 31. 2008. The bill would require that any transfer agreement that is executed on or after January 1, 2008, and on or before June 30, 2008, contain a requirement that the county pay an additional amount annually, to be calculated pursuant to a specified method. The bill would provide that the county is not required to make the additional payment if the county, before January 1, 2008, has submitted a proposed county facilities payment in connection with court facilities. The bill would further require that any transfer agreement that is executed on and after July 1, 2008, contain a requirement that the county facilities payment be calculated pursuant to the greater of 2 specified methods. The bill would make related, conforming changes. This bill contains other related provisions and other existing laws.

#### SB 649

(Committee on Judiciary ) Trial court restructuring.

Status: 07/12/2007-Chaptered by the Secretary of State, Chapter Number 43, Statutes of 2007

Current Location: 07/12/2007-S CHAPTERED

**Summary:** The California Constitution provides for the abolition of municipal courts and their unification within the superior courts, as specified. This bill would conform various statutory provisions of law to the abolition of municipal courts and their unification within the superior courts. The bill would also make related statutory changes with respect to the classification of limited civil cases, appeals in limited civil cases and misdemeanor and infraction cases, and arraignment by 2-way electronic audio video communication. This bill contains other related provisions.

#### SB 823

(Perata [D]) Private postsecondary education: California

Private Postsecondary Education Act of 2007.

Status: 08/31/2007-Hearing postponed by committee. (Refers to 8/30/2007 hearing)

Current Location: 08/31/2007-A APPR. SUSPENSE FILE

Summary: The Private Postsecondary and Vocational Education Reform Act of 1989 generally sets minimum standards of instructional quality, ethical and business practices, health and safety, and fiscal responsibility for private postsecondary and vocational educational institutions, INCLUDING PRIVATE COURT REPORTING SCHOOLS, as defined. The act establishes in the Department of Consumer Affairs the Bureau for Private Postsecondary and Vocational Education, which, among other things, is required to review and investigate all institutions, programs, and courses of instruction approved under the act. This bill would recast, revise, and reenact the provisions of the Private Postsecondary and Vocational Education Reform Act of 1989 as the California Private Postsecondary Education Act of 2007. The bill would establish the Board for Private Postsecondary Education in the Department of Consumer Affairs, and would provide that the board would generally succeed to the duties assigned to the bureau under the 1989 act. The bill would repeal the California Private Postsecondary Education Act of 2007 on January 1, 2015. This bill contains other related provisions and other existing laws.

Chair to develop technology seminars for the annual convention, including audiosync seminars, Vista operating system seminars, digital signature seminars, and Windows seminars.

Another goal of the committee was to research new technology tools as it relates to the court reporting field. A column for *CCRA Online* was developed that we named CAT Nips. Articles were written for StenoCat, CATalyst, Eclipse, and ProCat on a monthly basis highlighting tips for each software vendor. Due to the huge success of this program, it will become a regular feature in *CCRA Online*.

The Technology Committee is instrumental in furthering legislative efforts for further technological advances in court reporting through the research of new technologies and applying those technologies to the court reporting field.

A successful study was completed of RealLegal Exemplaris, an online transcript repository for official reporters. Exemplaris allows official reporters to add their transcripts to their private, secure online workspace. Customers search the public portion of the repository to locate the transcript applicable to their research. Using their credit card, customers may purchase the transcripts and download them for immediate use. It was determined this is an excellent way for official reporters to make their transcripts available for sale to the public.

Audiosync, use and misuse, has become a hot topic this year. The Technology Committee worked with other committee chairs on the guidelines/issues of the subject, culminating in an Audiosync discussion panel seminar at the convention.

CCRA's CRR Tips & Tricks E-seminar continues to be a successful e-seminar available to our members as well as nonmembers.

Technology is a strong theme in this year's convention, and the Technology Committee worked with the Convention Chair and/or Continuing Education Chair in developing technology seminars for the annual convention.

*CCRA Online* continues to be the "face" of the association. The Technology Committee has been instrumental in submission of many technology articles and education pieces in regard to new and emerging technology, as well as existing technology.

Transcript repository issues were investigated regarding the uploading of official and deposition transcripts available from Web repository sites, including TrialSmith, without payment to the reporter. A cease and desist letter sent to TrialSmith, by CCRA president Sandy Bunch Vanderpol, resulted in immediate removal of all California official transcripts from their Web repository. This year Microsoft Windows released Vista, a new operating system. The technology committee developed information relating to court reporting software compatibility issues that may arise, writing articles in that regard for CCRA Online. One of the convention's seminars will also address that subject.
